The Role

- Experience of delivering credible near-term and long-term Net-Zero Targets and associated strategies;
- An understanding of the Science Based Targets initiative (SBTi)
- Excellent research & data analysis skills, including manipulation of large datasets;
- Strong verbal and written communication skills, including technical report writing; and
- Demonstrable experience in applying creative, practical, and common sense thinking to solve real-world problems.

The "icing on the cake" might be previous consultancy experience, or complex LCA project experience, or having worked with multi-national/global companies in relation to overseas operations.
